9.6.2 Lo-fi Interview Questions and test plan

Introduction

"Thank you for joining today. My name is ______, and I'll be leading this session, which is for a Capstone Human-Computer Interaction Masters class at DePaul. We are conducting a usability test to evaluate the AR Digital Creation Platform prototype that we are developing. My pronouns are (say pronoun). Definitions – to make sure we are using the same terminology

<u>Augmented reality:</u> Augmented reality is an interactive experience of a real-world environment where the objects in the real world are enhanced by computer-generated perceptual information.

<u>Creation Tools:</u> Tools that assist people in creating digital and non-digital content such as documents, art, photography, music, games, tools etc.

Background Interview

To get started, I would like to get to know you a bit:

- 1. Have you ever heard about Augmented reality?
- a. On a scale of 1 to 5, how aware are you of Augmented Reality (AR) experiences? (1 is Not at all Aware, and 5 is Extremely Aware)
- 1. Have you created AR content?
- On a scale of 1 to 5, what is your level of familiarity with creating AR experiences? (1 is Not at all familiar, and 5 is extremely familiar)

Usability Tasks

Now we will jump into the usability test, and I will provide you with a link to the prototype of the chat. Please, open that link and then begin sharing your screen. I will provide a brief scenario and ask you to complete a series of tasks. When performing tasks, remember to THINK OUT LOUD, describing your thinking process. For example, talk about:

- 1) What you are planning to do next
- 2) Reasons behind your selections
- 1) The challenges you face (if any)
- 2) If anything is confusing or unexpected

You may ask questions during testing, but please know that I may not answer them if I feel like it will affect how you would interact with the prototype if I were not here. Are you ready to begin?"

Scenario:

Imagine your name is Morgan, and your good friend from school is visiting you and your family after many years in Canada. You wanted to share a few fond memories of your time to make them feel welcome. Your colleague at work mentioned that there is AR software that could help create a fun greeting card experience to share those memories.

- Can you walk me through how you would successfully create an account and land on the homepage? Remember to speak aloud, explaining your thoughts and the reasons behind your selection. Once you have completed this, please let me know.

- How likely are you to use a product compared to an e-card or a physical greeting? Please explain your answer.
- What are your thoughts about having a verbal/voice integration feature in our AR platform?
- (If asked, what does it mean, say for example, in the scenario we walkthrough, adding a personalized verbal message in addition to text, to the greeting card).

Demographics Questions

- What is your occupation?
- What age range do you fall into? (18-24, 25-34, 35-44, 45-54, 55+)
- What is your ethnicity?
